My lord efter maist hartlie commendatiounis. I rasavit your Lordshipis writting  
ye fowrt day of August dattit ye xvij of Julii bypast schawing the  
maist vickitt and vngodlie prosydingis of ye Glengrigore. And for offenses  
making to zowr Lordship and zowr fryndis dissyring me to expell thame my  
cuntry vderwayis zowr Lordshipis fryndis ye serwandis ze haif send vill wse  
extremitie on all thame yat ar assistaris and mantenaris of thame. I  
dowt nocht bot zour Lordship knawis yat I wes newer favorare nor mantienar  
of vickitt nor vngodlie personnis bot rathare ane punnischare of thame  
gyf I haif neglecitt my dewtie in yat caise in onny tyme it is thr(ow)  
ye favore I buire to zowrslf becaus sum men allegitt yame to be z[owr]  
serwandis and as to my awin part zit as of before I thynk newer (to)  
be favorare of ye Clangregore nor na vyeris yat vssis sic abominabill (crymis)  
as zowr Lordship speikis of zit vyth zowr Lordshipis pardoune I man remember (zow)  
and ze wor maire circumspek to zowr dewtie toward zowr fryndis (and)  
serwandis thaire vald nocht be sa greitt cummer in ye [cuntry as yair is. I]  
will nocht expoune yis bot lat zowr Lordship iudge this (as ze) thy(nk gude.)  
I beleive zowr Lordship vill nocht thoill zowr serwandis to do (ony) thyng (to me)  
or myn bot yat thyng yat is honest and rasonabill and zour Lordship (hes)  
newer findd vther occatioune the awld kyndness yat hes indurit  
hundreth zeiris sall nocht fail in my part. And gyf onny on-  
fryndis vald perswad zowr Lordship to do by zowr dewtie I vill nocht beleive  
zowr Lordship vill apply yairto. And als I villed layth [to] suffer vrang quhat  
I may do to zowr Lordshipis plesure salbe raddie [in ye awld] maner. And  
God be zowr Lordshipis keipare. At Drymmen ye [fowrth] day of August.
