



Children's Hearing System



In 2011 research **50%** of children and young people were in a state of anxiety before their children's hearing (SCRA 2011, page 13)

In a 2011 study **55%** of children and young people said they felt negative feelings during their children's hearings. (SCRA 2011)

Children and young people often do not look forward to their children's hearings. **50%** of participants in SCRA Report could not give an example of a children's hearing that went well (SCRA 2011, page 24)

Placement Moves and Transitions

Looked after children often come into the care system via a crisis

They can have multiple placement moves, sometimes out of their local authority area

Placement moves can sometimes be sudden for children

Children can have as many as 45-50 different placement moves









Staff/Police/YOI Relations

Young People can become offenders whilst in care due to charges from absconding or crisis situations occurring in their placements

Young people can be 'unrulied' by their staff and Police during crisis situations

Police and YOI do not receive mandatory training on understanding looked after children's issues

Very few staff members working in Polmont YOI have any previous experience of working with young people

Exclusion



Exclude or not to exclude, that is the argument (2012)

'I'm not talking about kids with identified additional needs, but pupils who indulge in acts of violence. A particular problem is looked after and accommodated children who seem impossible to exclude'

General Secretary of Scottish Secondary Teachers Association

The **overall exclusion** rate in 2010/2011 for looked after children were **326 per 1,000** for looked after children, compared with **40 exclusions** per **1,000 pupils** for all school children.

Edinburgh University (2013) researched the relationship between school exclusion and later outcomes for young people; it revealed that a child who is excluded from school by the age of 12 is four times more likely to end up in prison by the time they reach age 22.








YOI & Prison

It is estimated that 50% of the adult prison population were looked after children

No staff in Polmont are trained in Youth Work skills

Other estimations were that as many as 75% of young men in Polmont YOI were formerly in care

Does prison rehabilitate or Institutionalise?



Relationship role






The **rights** of the child are protected and stronger where the **relationship** around them is strong and held in place


